We hereby acknowledge that (i) this declaration shall be considered as supplemental to the Letter of Request we provided to Clearstream and (ii) all provisions contained into the Letter of Request are applicable to this declaration.

We irrevocably authorise Clearstream and its depository BNP Paribas S.A. to provide the present declaration or a copy hereof, and any document or information submitted to Clearstream pursuant to this declaration, to the appropriate authorities, including Dutch Tax Authorities.

We hereby understand that this declaration does not constitute a guarantee of any tax refund of any kind and Clearstream might ask us to provide other documents if requested by the Dutch Tax Authorities.

This declaration is to remain in full force unless this declaration is otherwise terminated by revocation of (name of client) _____, Clearstream or BNP Paribas S.A..
