- In case the withholding tax is refunded by the Luxembourg Tax Authorities directly on the cash account of the beneficial owner, we undertake to inform LuxCSD immediately after the receipt of the funds by the beneficial owner. Additionally, we acknowledge that LuxCSD reserves the right to stop the service if we fail to comply with this undertaking in a repeating manner;
- The tax reclaim service offered by LuxCSD and by the agent for the Security may be subject to changes depending on the Luxembourg Tax Authorities requirements;
- Neither LuxCSD nor the agent guarantee the acceptance of the reclaim or payment of the refund by the relevant Tax Authorities; and
- LuxCSD shall not at any time be held liable for any loss or damage caused by the tax reclaim procedure and shall be held harmless in respect of any liability arising from any action taken in relation to the tax reclaim procedure.

We assume full responsibility for the accuracy, completeness and validity of the information contained in this Letter of Request and will hold LuxCSD harmless for any claim or liability in relation to the content of this Letter of Request.

We hereby warrant on a continuing basis that each of the signatories hereto and with respect to all documents submitted from time to time in relation to the Security has full power and authority to sign on behalf of the customer of LuxCSD mentioned below.

We understand and agree that signing this Letter of Request does not guarantee a tax refund.

This Letter of Request is governed and construed in accordance with the laws of the Grand Duchy of Luxembourg and the courts of Luxembourg shall have exclusive jurisdiction for all legal proceedings relating thereto.
